AN ORDINANCE ESTABLISHING A CROSSWALK, AS THAT TERM IS DEFINED IN THE TRANSPORTATION CODE OF THE STATE OF TEXAS, ON PANHANDLE AVENUE ON THE WEST SIDE OF ITS INTERSECTION WITH 13TH STREET, DEFINING ITS DIMENSIONS, REQUIRING THAT IT BE MARKED WITH SURFACE LINES, PROVIDING FOR SEVERABILITY, PROVIDING A PENALTY AS PROVIDED BY STATE LAW, PROVIDING FOR PUBLICATION, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the governing body of the City of Slaton has determined that the safety of pedestrian traffic on Panhandle Avenue at its intersection with 13th Street, requires that there be established a marked pedestrian crosswalk, NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION FOR THE CITY OF SLATON, TEXAS:

SECTION FOUR: PENALTY. Vehicular traffic failing to yield the right of way to pedestrians within the crosswalk shall be fined consistently with the penalty provided by state law.
