The Lubbock County Water Control and Improvement District #1 (LCWCID#1) will receive bids for construction of an equipment storage barn at the Buffalo Springs Lake until 10:00 a.m. the 3rd day of September 2019 at 9999 High Meadow, Lubbock, TX 79404 at which time and place all will be publicly opened and read aloud.

Bids are invited upon the several items and quantities of work as follows:

Item 1: Demolition of existing structure, Construction of new 3 sided 100'x35' barn, 16' tall front of barn and 14' in the rear, located at Buffalo Springs Lake. Bids shall also include, with and without electricity and concrete foundation.

Criteria for the selection of qualified contractors will include: proof of workers compensation insurance, verification of quality work references, verification of credit references, verification of established line of credit, local contractor, and established builder.

A certified check or bank draft payable to the order of Lubbock County Water Control and Improvement District #1, negotiable U.S. Government bonds (at par value) or a satisfactory Bid Bond executed by the Bidder and an acceptable surety in an amount equal to five percent (5%) of the total bid shall be submitted with each bid.
