Bids are invited for several items and quantities of work as follows in Slaton, TX:

1. West side of N. 9th St. from W. Lynn St. to W. Garza St.
2. North side of W. Garza St. from N. 8th St. Westward approximately 162 linear feet
3. Corner of N. 8th St. and Texas Avenue
