ORDINANCE NO. XXXIV

AN ORDINANCE ENACTED BY THE BOARD OF DIRECTORS FOR THE LUBBOCK COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE, OF LUBBOCK COUNTY, TEXAS, UNDER THE POWERS, AUTHORITY AND PROVISIONS OF TITLE 128, CHAPTER 3-A OF VERNON'S ANNOTATED TEXAS STATUTES, INCLUDING ARTICLE 7880-7 OF SUCH STATUTES, MAKING IT ILLEGAL TO HAVE IN POSSESSION OR IN USE WHETHER OR NOT IN IMMEDIATE POSSESSION OF ANY PERSON, ANY GLASS BOTTLE OR GLASS CONTAINERS OF ANY KIND, SIZE, OR SHAPE WITHIN THE PERIMETER OF THE LAND OWNED, CONTROLLED, AND OPERATED BY LUBBOCK COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE BUFFALO SPRINGS LAKE AREA REFERRED TO HEREIN AS THE BSLA, PRESCRIBING PENALTIES FOR VIOLATION OF THIS ORDINANCE; PROVIDING A REPEALING CLAUSE; PROVIDING A SAVINGS CLAUSE; AND PROVIDING FOR PUBLICATION AND EFFECTIVENESS OF THIS ORDINANCE.

BE IT ENACTED AND ORDAINED BY THE BOARD OF DIRECTORS FOR THE LUBBOCK COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NUMBER ONE OF LUBBOCK COUNTY, TEXAS:

SECTION 1 POSSESSION OF GLASS CONTAINERS

It shall be illegal to have in possession or in use, whether or not in the immediate possession of any person, any glass bottle or glass containers of any kind, size, or shape within the Buffalo Springs Lake area.

SECTION 2 PENALTIES

Any person violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor, and upon conviction therefore, shall be fined in any amount which, combined with cost of court, shall not exceed the sum of Two Hundred and 00/100 dollars (\$200.00).

SECTION 3 REPEAL OF INCONSISTENT ORDINANCES

All Ordinances or parts of Ordinances inconsistent or in conflict of the provisions of this Ordinance are hereby repealed including but not limited to Ordinance No. XXIII dated May 28, 1991.

SECTION 4 SAVINGS CLAUSE

In the event any particular provisions of this Ordinance, or any portion of any clause or paragraph thereof, is judicially declared to be invalid, nevertheless, those parts of this Ordinance and its several paragraphs and subdivisions that shall remain after such declaration shall have full force and effect.

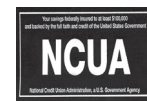
