as a Board member earlier this year. He said he was excited about the position, happy to be able to represent West Texas from North Potter County to Bailey County all the way down to Gaines County.

The Slaton Bakery Students and Teachers of the Month were announced. They were, from Stephen F. Austin Primary, Jazavion McDaniel and Anjanette Franklin; Cathelene Thomas Elementary, Lilly

Guthrie and Mary Smith; Slaton Junior High, Gracyn Funderburk and Rebecca Castillo and Slaton High School, Evan Lopez and Sherri Arrington.

A COVID update was presented. Arrington said they were working with the County and would have a COVID clinic for teachers, which was conducted last Friday (Jan. 14). They also send weekly COVID reports to the State.

Superintendent Jim Andrus gave an update on enrollment. The District is currently at 1,277 students, and still down 54 from last year.

Slaton Junior High School was the featured school for the month. Among items presented included discussing data received by students on the first semester of school, leadership classes and other programs they were conducting to help get students more involved and feel a sense of community among fellow classmates.

In academics, reports on reapplying for the School of Innovation and STAAR testing were given. The Junior High and High Schools will be taking a field STAAR test in two new studies for the State to see if they will be added to the main test. The High School will take a history test and the Junior High will take an algebra test. These tests will be conducted Feb. 14-20.

A report on athletics was also given focusing on the spring sports.

Mike Hernandez with maintenance reported the Tiger Den Daycare Center was nearly completed and needed its certification, some winterizing and repairs were done in the schools. They also are preparing the Wall of Honor for

the High School and will be working on lighting, batting cages and concessions at the softball diamond.

The Board then went into executive session. When it convened, the Board approved updates to the School Board Policy, travel reimbursement rate, TASB insurance and FIRST rating.

The Board also approved all items needed to conduct an election for Trustees. Both At-Large positions, currently held by Kara Newcomb and Justin Martin, are up for election.

They also approved the

purchase of another special education bus, which features a wheelchair lift. Andrus said there are three and the oldest one would be used in emergencies. The funds are taken out of the special needs account.

During public forum, two people spoke on issues and concerns about the schools. One addressed a complaint about the review of a bullying incident on her daughter while the other addressed concerns about a new officer who was hired and wanted the Board to research deeper on the hiree.

"Early on during the application process, I became aware of the difficulty of getting in. However, this was a goal of mine, and I was determined to do all that I could to give myself the best shot. After all the work I put in, I am extremely honored and thankful for being accepted."

His decision to apply for West Point too also stemmed in a high value for discipline. "I started considering the possibility of just enlisting into the military right after high school, but I remembered the Military academies," he said "After researching the military branches and their academies, the Army's values and types

of service sparked my interest and pulled me into applying for West Point."

He said there were several steps to apply, such as a questionnaire to see if he was a good fit, then a candidate profile filling out his academic, athletic and extracurricular ac-

In addition, he had to write multiple essays, get evaluations and recommendations from teachers and coaches, do an interview, score high on the SAT and ACT, and take the standard physical and fitness tests that would be needed to attend West Point.

He also had to have one more step that most schools don't have - a nomination from a Senator or Congressman.

"The process for receiving a nomination added on to the requirements. After sending

additional essays, letters and records, I participated in an interview with Jodey Arrington's staff, and a few months later I received the nomination from Congressman Arrington. Finally, my profile was complete and only time would tell if I was to be accepted in," said Trevino.

All the hard work though paid off and he got the call he was accepted. "I called my mom and dad soon after receiving the call from Congressman Arrington, and I could hear the excitement in their voices. Both of them told me how proud they were of me and I am glad I was able to share that moment with them," Trevino added.

While he is excited to go to West Point, Trevino still has a half semester left before he graduates Roosevelt. The 2021 State football bronze medalist said he was blessed to be part of the longest season in the school's history and to play with his "lifelong brothers." He will also take part in powerlifting, track and baseball this spring.

He's also enjoyed his classes, especially pre-calculus.

But this isn't all he's doing. "I will have a few band competitions this spring, competitions for (Future Business Leaders of America) and our rocketry class will launch our rocket near the end of the school year. Of course, I am looking forward to Prom, where I will take tons of pictures that will make my wonderful mom and girlfriend happy," he said. "All iokes aside though, graduation is coming up and the next chapter of my life is about to begin. I am going to take each

day one at a time, and cherish these moments that I have with my family, friends and mentors."

Trevino thanked the Acuff community and those around it for the support he has received this past year. "I hope that I can inspire others, and show that while where we grow up can define our character, it does not define the success we can
